Title I, Part A Schoolwide Program Purpose and Intent

- ***Purpose and Intent: To ensure that all children receive a high-quality education, and to close the achievement gap between children meeting the challenging State academic standards and those children who are not meeting such standards.***

- Title I, Part A provides resources to help schools with high concentrations of students from low-income families provide high-quality education which will enable **all** children to meet the state student performance standards.

Schoolwide Campuses:

- The Title I, Part A funds received by the district are used to upgrade and enhance instructional programs for **all** children on TIA campuses and are consolidated on the schoolwide campus.

- Funds may be reserved at the district level for the following activities:
 - Parent Involvement Activities - if TIA entitlement is over \$500,000
 - Preschool Programs
 - Administration of the program
 - Districtwide Professional Development Activities
 - Homeless students if not attending a Title I campus-must reserve
 - Neglected/Delinquent Facilities
 - Foster Care Transportation
 - Other: technical assistance for TIA programs, summer programs

Title I Program coordinates with other programs in the district:

- Title II, Part A – 100% of TIIA funds are used to meet the intents and purposes of Title IA through REAP or Transferability
- Title IC- Migrant-
- Title III, Part A- Limited English Proficiency
- Title IV, Part A - 100% of TIVA funds are used to meet the intents and purposes of Title IA through REAP or Transferability
- Title V, Part A or USDE SRSA
- Other State and Local programs
- Programs that support students in passing the required State Assessments

The Title I, Part A Program is a federal program under ESEA/Every Student Succeeds Act (ESSA) that is monitored by TEA during the year

Medical

- Law – Form must be signed for Mrs. McCrary to provide any needs.

Cell Phone Policy

- ❑ **NO Cell phones, NO Personal laptops, NO Air pods** allowed during the instructional day.
 - Secondary – allowed at lunch only
 - Elementary – No Cell Phones
- ❑ If Caught in Class or Hallway with phone...
 - 1 – Teacher takes it up (Pick up from teacher)
 - 2 - Brought to office (Student pick up from Principal)
 - 3 – Brought to office (Parent must pick up) ¹⁷

Attendance

- ❑ State Law requires students to be in attendance 90% of the school year. This means no more than 7 absences per semester.
- Secondary (6th–12th) – Attendance taken every period
- Official Attendance taken at **9:00am**
- **Must notify the office for any reason the student is absent. (Doctor note and/or phone call)**
